FOR AOPA MEMBERS AND THEIR SPOUSES

FI IGIBII ITY

All members in good standing residing in the United States between the ages of 50 and 74 are eligible to apply for coverage as long as they are able to perform the daily living activities of a person of like age and sex. A member's spouse residing in the United States between the ages of 45 and 74 may also apply for coverage as long as they are able to perform the daily living activities of a person of like age and sex.

Members and spouses can select a life insurance amount of \$5,000 to \$50,000 (in increments of \$5,000). The coverage is available only to residents of the United States and may not be available in all states. Please contact the administrator for details.

PLAN FEATURES

No Medical Exams

You don't need a medical exam. You don't need to have your doctor send in your medical records. A physical exam, EKG, blood test or other medical information may be required. If so we will arrange for an independent professional paramedic to contact you and arrange to perform these simple tests at your convenience. The exam and the blood test will be paid for by the Plan.

Beneficiary Selection

You may name anyone you wish as the beneficiary of this Plan, and you may change the beneficiary by contacting the Insurance Administrator in writing and advising them of the change.

You may also choose to name a beneficiary that you cannot change without his or her consent.

This is an irrevocable beneficiary.

Effective Date

Your or your spouse's insurance will become effective on the first day of the month on or after the later of the following dates:

- MetLife approves your and your spouse's proof of good health;

Exclusions

We know that you buy our products and services because you trust us. This notice explains how we protect your privacy and treat your personal information. It applies to current and former customers. "Personal information" as used here means anything we know about you personally.

SECTION 1: Plan Sponsors and Group Insurance Contract Holders

This privacy notice is for individuals who apply for or obtain our products and services under an employee benefit plan, group insurance or annuity contract, as an executive benefit, or as otherwise made available at your work or through an association to which you belong. In this notice, "you" refers to these individuals.

SECTION 2: Protecting Your Information

We take important steps to protect your personal information. We treat it as confidential. We tell our employees to take care in handling it. We limit access to those who need it to perform their jobs. Our outside service providers must also protect it, and use it only to meet our business needs. We also take steps to protect our systems from unauthorized access. We comply with all laws that apply to us.

SECTION 3: Collecting Your Information
